Stay safe during a breakdown!

In case of a breakdown, it is important to take the following measures:



Stop in the emergency lane (hard shoulder) and turn on your hazard lights



Put on your reflective safety vest



Place the warning triangle 100 feet (330 feet on highways) behind your vehicle



Take shelter behind the safety barrier and notify the police or third party assistance
